I. Introduction

The Office of the Illinois State Treasurer (the "Treasurer") is issuing this Procurement Notice to proceed with the immediate selection of Hanson Professional Services, Inc. ("Hanson"), as a subcontractor to FWAI Architects, Inc. ("FWAI"), for additional design work under the Treasurer's existing contract with FWAI for the design of needed renovations at One East Old State Capitol Plaza (the "Chase Building"). This selection is completed in the best interest of the State, pursuant to Section 50 of the Architectural, Engineering, and Land Surveying Qualifications Based Selection Act (30 ILCS 535/50; the "QBS Act").

Under a prior small purchase, in accordance with Section 45 of the QBS Act, Hanson provided a structural assessment of the Chase Building. This assessment included several recommendations for structural improvements (the "Improvements").

Prairie Engineers, P.C. ("Prairie") has provided services under a subcontract with FWAI, but is unavailable to assist in the design and implementation of the Improvements. Further, given Hanson's familiarity with the need for the Improvements, it is in the State's best interest to ensure the efficiency and expediency of utilizing Hanson to design those Improvements, under the umbrella of the overall design provided by FWAI.
