MINUTES

1) Call to Order/Welcome and Introductions

The meeting was called to order by Treasurer Michael Frerichs at 3:05 PM.

Treasurer Frerichs acknowledged the long and distinguished service of former committee member Emilia DiMenco. Emilia DiMenco thanked the committee and the Treasurer for establishing the program and its ongoing success. Treasurer Frerichs welcomed Patricia Mota to the Charitable Trust Committee. Patricia Mota introduced herself and shared brief remarks.

2) Approval of Minutes from December 3, 2020

4) Report on Fall 2020 Site Visits and Grant Agreements

Alex Armour provided an update on the Fall 2020 site visits. A discussion was held about an organization that did not have a successful site visit. Catherine Shannon asked about the timing of grant payments for the previous round of grantees. Alex Armour provided an update on scheduled payments.

5) <u>Report on Charitable Trust Fund</u>

Alex Armour provided an update on the status of the Charitable Trust Fund. Catherine Shannon informed the committee that the Treasurer's office would be seeking a \$1M appropriation for the program for FY 2022. Dale Morrissey inquired about long term plans for the Charitable Trust Committee and Fund. Alex Armour said that the Treasurer's office would discuss several options and present them at the September 2021 committee meeting.

6) <u>Legislative Update</u>

Catherine Shannon provided an update on the Charitable Trust legislation, HB 11, introduced by Rep. Debbie Meyers-Martin. The legislation was reintroduced from the previous session and would raise the maximum operating budget for organizations from \$1M to \$2M. The bill has been assigned to committee.
