Actions the Treasurer has undertaken to use Illinois businesses for construction and construction-related professional services include direct solicitation of Illinois businesses; coordination with the Illinois Capital Development Board to include required Illinois prequalification and licensure where applicable; and, requesting and reviewing information from respondents regarding prior projects in Illinois.

Both awards during State Fiscal Year 2024 for construction projects were made to Illinois businesses, representing 100% utilization of Illinois businesses.
